

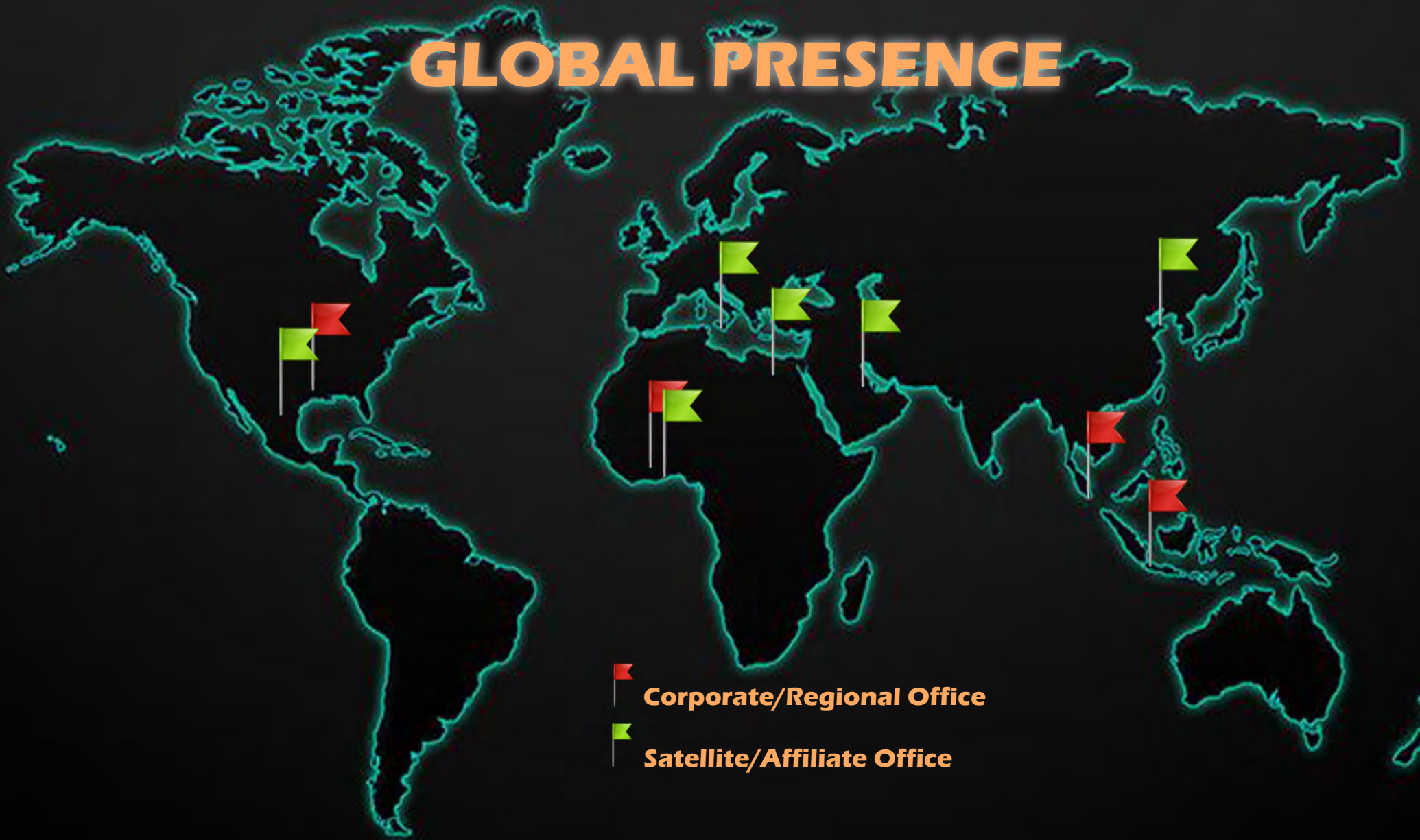

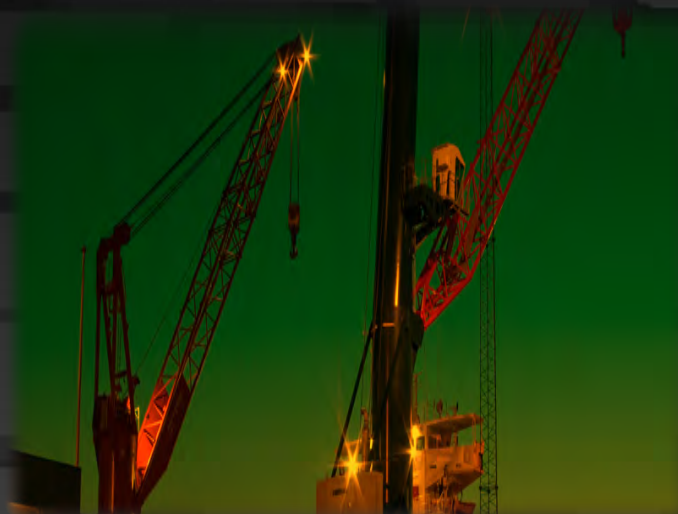
Our strategy is to maintain our client focus. Forging close and mutually beneficial relationships with our clients will result in overall success and timely project completion.
